

**PARTICIPANT LIABILITY WAIVER for  
EMPOWER HAITI TOGETHER LLC**

**Please read this form carefully. By signing this agreement you are waiving and releasing rights you might otherwise have to seek compensation in case of injury, death, loss or damages as a result of your participation in the activities of EMPOWER HAITI TOGETHER LLC.**

I wish to participate in the activities of Empower Haiti Together LLC. In return for Empower Haiti Together LLC and any affiliated organization allowing me to participate in their activities, which I agree is adequate consideration for this agreement, I, the undersigned person, for myself, and as the parent or guardian of any child whose name appears below, hereby agree as follows for myself and for any child whose name appears below:

1. I am freely volunteering to participate in the activities offered by Empower Haiti Together LLC and I understand that there could be dangers involved in the activities I will be participating in, including, but not limited to: dangers associated with travel including but not limited to airplane, car, foot, and public transportation; exposure to illnesses including but not limited to food, water and insect-borne illnesses; exposure to sharp objects; dangers associated with terrorists, etc.. I understand that I am entirely responsible for deciding whether to participate in any activities with Empower Haiti Together LLC, and for deciding what activities in which I can safely participate.

I hereby agree for myself and for my heirs, relatives, representatives, estate, agents and assigns, that I will not hold liable Empower Haiti Together LLC, or any of the persons listed in Paragraph 4 below, and that I will waive and release any claims, demands or actions against them, for any damages to, or loss of, my property or my child's property, or for my, or my child's, injury or death, which results from or arises in connection with any of the activities of Empower Haiti Together LLC, other than that which results from gross negligence. I understand that this waiver includes a waiver of liability for acts of negligence. In addition, I agree to indemnify the organization and the persons listed below for any claims made against them, on my behalf, on my child's behalf, or otherwise, as a result of any damage to, or loss of, my property, or my child's property, or as a result of my injury or death, or my child's injury or death, resulting from or arising in connection with the activities of Empower Haiti Together LLC, other than that which occurs as a result of the gross negligence of Empower Haiti Together LLC or the persons listed in Paragraph 4 below.
3. I have filled out the Permission Form for any event that requires one and included therein any pre-existing conditions or important medical information for myself or my child.
4. The persons and organizations covered by this agreement include: Empower Haiti Together LLC and its directors, officers, members, staff, employees, volunteers, agents and representatives, and any others who participate in the activities of Empower Haiti Together LLC, or who volunteer for, or perform work for, Empower Haiti Together LLC.
5. I am aware that I must obey all rules, regulations and instructions (including verbal and written instructions) given by Empower Haiti Together LLC and I understand I will be subject to appropriate disciplinary action for violations of these rules and regulations, including but not limited to being sent home from the trip.
